Work Outlook As the Country suffers through its highest level of unemployment, for the most part Local 8 has been able to keep our heads above water. In order for members to maintain their income levels, you must be willing to take all calls and answer your phone twenty-four seven. While these changes can be annoying, the alternative could be worse. For those members unable to pay your union obligation, contact the Office for an appearance at the Executive Board. The bookings at the Academy and Merriam has started as well as some shows at the Convention Center. Annenberg has a number of days booked in October and the Wachovia Center is scheduling shows to coincide with the closing of the Spectrum. The Pennsylvania State budget passed this weekend and looks to include the Film Tax Incentive which will generate jobs in the movie Local. To maximize your earning potential; 1) Advance your skills be it rigging, Board Op, A.V. or Shop work. 2) Answer your phone. 3) Take all the work that is available to you. Remember you are not just earning your paycheck, but are also building up your medical and retirement benefits.

YEAR OF SERVICE. The membership of Local 8 at the April Meeting voted to eliminate any earnings outside Local 8 towards a Year of Service. Based on the advice given to us by the Local 8 attorney, the Executive Board voted that this policy should not be implemented four months into a calendar year and will begin January 1, 2010 unless changed by the membership before that date. If you are paying percentage on earnings outside of Local 8 for 2009, you can pay up to \$10,750 dollars.

Dear Brothers and Sisters,

As reported this past Summer, Local 8 sent a delegation to the IATSE Quadrennial Convention. Last week, I had the honor of being one of the six delegates from the IATSE sent to the AFL-CIO Convention in Pittsburgh. As with our own convention, the AFL-CIO needed to update its constitution, set finances, pass resolutions and elect officers. During the convention, the eight hundred union delegates were addressed by President Obama, Senators Specter and Casey as well as a number of other local and international labor leaders.

At any given time in history we have all heard that this is the moment, this is the time that we need to act to change and determine our future. Given what I heard at the last two conventions, I firmly believe this is true. There is no doubt this is the most pro-labor President we have had in office in our lifetime. Couple this with the majorities the Democrats have in the House and Senate and it adds up to the best opportunity we will have to re-establish organized labor as a force in this country. President Obama's message to the AFL-CIO was clear; rebuild the American economy through a strong middle class and recognize Organized Labor as part of the solution not the problem. President Obama has appointed Hilda Solis as the Secretary of Labor. I suggest you Google Secretary Solis to get a true indication of who she is. Her pro-labor votes and positions are to numerous to include in this Newsletter. President Obama has also committed his full support to the Employee Free Choice Act. This law when passed will be the best law for labor since the 1935 Wagner Act. The Wagner Act gave unions the RIGHT to organize and was the leading cause for the growth of unions. This law along with GI Bill of WWII strengthened and educated the workforce that provided America with its best economy for decades. President Obama's stimulus package, though highly critized at the time, prevented America from going into a depression. His plan to increase the rights of workers to allow them to join a union and negotiate a fair contract will rebuild the middle class. His plan to invest in alternative energy programs rather then waste money in the Middle East to protect other countries energy reserves will create the jobs we need in this country while lessening our dependence on those that want to hurt this country. Rebuild the middle class through union jobs created to lessen our dependency on foreign oil. It would be simple if not for the politics.

President Obama is currently engaged in a battle to fix health care. Concerns regarding the double digit inflation workers were forced to pay were ignored until this President. Obama's message was clear at the Convention, without a public option, health care cost will continue to increase and prevent middle class working Americans the ability increase their wages or fund their retirements.

I began working as a stagehand in 1980, the year the Great Communicator Ronald Reagen took office. Reagen's decision at the beginning of his first term to take on the Air traffic Controllers Union set the trend for twenty-eight years of attacks on unions. Over the twenty-eight years the anti-union politicos weakened the unions, weakened the middle class and weakened the economy. The advances in the stock market and wealth generated by Americans over this time was paper wealth generated by the Stock Market and Housing Bubbles. Just like in 1935 when the Country needed real solutions, the Employee Free Choice Act, health care reform, market regulation and the rebuilding of the middle class through unions needs to take place. I am looking forward to having Local 8 lead the charge to rebuild the labor movement in our City and our Country.
