If you were on the B or D List in 2016, you owe your stamps. Stamps are currently \$70.00 per quarter, \$280.00 per year. Members on the Road are required to submit their dues timely. If you are paying percentage on entertainment work outside Local 8's jurisdiction, take advantage of our new online payment option located on our website under Online Store. As per Article 19 Section 26 of the International's Constitution, if you are a member of Local 8 working under the jurisdiction of Local 52, you owe Local 8, 1% of your gross earnings. This does not apply to Local 8 members who have a 52 card.
